O R D E R: -

In compliance of the orders issued by the Hon'ble High Court in the reference 5th cited and in the circumstances reported by the Commissioner /Director of Intermediate Education, Telangana, Hyderabad, in letters 4th & 6th read above and after careful examination of the matter, Government, hereby permit the Director of Intermediate Education, Telangana, Hyderabad to appoint Sri N.Ravindra Kumar, Contract Junior Lecturer in AET (Vocational) working in Government Junior College, Mancherial, Mancherial District against the sanctioned post in terms of the orders issued in G.O.Ms.No.16, Finance (HRM.I) Department, dated: 26.02.2016 from the prospective date i.e., the date of issue of appointment orders by the competent authority, subject to condition that:

- i. All the particulars furnished on file are genuine and true and the individuals are fully eligible in terms of educational qualifications, local status etc. as prescribed in the service rules.
- ii. The person now proposed to be regularized is fully eligible to hold the post in terms of G.O.Ms.No.16, Finance (HRM.I) Department, dated: 26.02.2016 read with Circular Memo. No.308-A/51/A3/HRM-I/2014, dated: 26.02.2016 and also in terms of the applicable special service rules read with Telangana State and Subordinate Service Rules.
- iii. No senior eligible person for regularization of their services is over looked /omitted.
- iv. If the individual is non-local to the proposed posts as per his/her local status, his case may be considered if he was appointed in the prescribed open quota for locals and non-locals as per service rules.
- v. It is categorically clarified that it is responsibility of the HoD for lapses if any in terms of the above issues as all details/records relating to contract personnel are being maintained by Higher Education Department.

02. The Director of Intermediate Education, Telangana, Hyderabad shall identify the suitable Roster Points in terms of P.O. 2018 as per the orders issued in G.O.Ms. No. 44, G.A. (Ser.D) Department, dated: 19.03.2022, at the time of issuing appointment orders.
